

POWERSPIN GAME GUIDE

Operator: OPAP S.A.

Participation in POWERSPIN

Powerspin is a fixed-odds betting game.

Participation in POWERSPIN is conducted under the provisions of the applicable legislation, of the General Regulation on the Organization, Operation, and Conduct of OPAP S.A. Games, of the Regulation on the Organization and Conduct of OPAP S.A. game "PAME STOIXIMA", as applicable, as well as under more specific terms and conditions laid down each time by OPAP S.A. and the HGC.

The aforesaid game of chance consists in the operation of a virtual wheel, which is comprised of 27 equal parts. Twenty-four (24) out of the twenty-seven (27) parts of the wheel depict all numbers ranging from 1 to 24, while the remaining three (3) out of the twenty-seven (27) parts depict one same symbol. Players select where the wheel stops. The position where the wheel stops designates the winning outcome.

If a player's prediction is correct, he/she wins the amount set forth in the prize table.

In essence, a draw constitutes the visualization of the draws' outcomes as generated by a Random Number Generator (RNG). The winning outcome is generated from the said draws. The RNG is certified by an independent company conducting controls in the games of chance sector.

Participation in POWERSPIN via Agencies is permitted to persons over eighteen (18) years of age.

It is clarified that:

Cancellation of a printed Entry Ticket is allowed provided that the selections made on the slip do not match those of the Entry Ticket. For instance, the Ticket includes different details due to a technical problem (e.g. selected numbers, number of consecutive draws) than those selected by the player on the slip he/she has presented for validation. Cancellation of entry is performed pursuant to article 5 of Fixed-Odds Betting Games Regulation.

Entry Fee

The entry fee per Column is set to twenty-five cents (€ 0.25). Players may participate in POWERSPIN with a simple column, by selecting a number, a symbol or a color zone.

Winnings Distribution System

As follows, please find the game categories offered.

Game Category: Number

Select one or more numbers from one (1) to twenty-four (24)

There are seven (7) available options under the number game category:

1. Number: Select one number to create a column holding one number

2. Doubles: Select two numbers to create a column holding a double
3. Trebles: Select three numbers to create a column holding a treble
4. Quadruples: Select four numbers to create a column holding a quadruple
5. Six numbers: Select six numbers to create a column holding six numbers
6. Eight numbers: Select eight numbers to create a column holding eight numbers
7. Twelve numbers: Select twelve numbers to create a column holding twelve numbers

To participate in each draw, players first select one of the aforementioned options and they subsequently opt for their preferred numbers. In case they do not select one of the aforesaid options, Number category is automatically selected.

Subsequently, they select the respective numbers, ranging from one (1) to twenty-four (24).

If the numbers selected are more than those designated under a game selection, then all possible combinations apply (e.g. three (3) selected numbers for Doubles game category will create three (3) Doubles' columns).

The maximum number of columns allowed is 20,000.

Hereinafter follows the column development table regarding up to 24 selected numbers.

The game allows for the selection of 24 numbers, provided that no more than 20,000 columns are created per game or combination or bet combination.

Column “Selected Numbers” includes the numbers selected, while the line refers to the “Game Category”.

For instance, if a player selects a treble game and opts for 6 numbers, then he/she will participate in the draw with all possible trebles of the six selected numbers, which generate 20 columns.

If the event is confirmed, the number of columns including it corresponds to the number of wins.

Symbol game category:

Symbol selection corresponds to three (3) positions on the wheel, equally distanced one from another.

Color zone game category:

The twenty-four wheel numbers are allocated across three (3) color zones. Players can bet if the wheel stops on one of the three (3) color zones.

Color zone options include red, blue, and green, and may be combined to create more columns.

Winnings’ payment is calculated per winning column.

Entry Fee

Column value is set to twenty-five cents (€0.25), per an OPAP S.A. BoD resolution. The minimum entry fee pertains to the development of one betting column.

The maximum wager amount per game or combination or bet combinations is set to a maximum value equal to 20,000 columns. In case the value of a wager exceeds the maximum amount each time set forth by OPAP S.A., the said wager will not be accepted.

Consecutive draws

A slip presents the following consecutive draws:

Two (2)

Three (3)

Four (4)

Five (5)

Six (6)

Ten (10)

Twenty (20)

Fifty (50)

One hundred (100)

Consecutive draws are also cumulative, when all the aforementioned amounts are selected.

Draws

Each draw for the designation of POWERSPIN winners is carried out every 4 minutes via an RNG, and is displayed on the screens found within the Agencies.

Winnings' Taxation

Winnings are taxed as follows:

Winnings up to 100 EUR: tax-free

Winnings from 100.01 EUR up to 500 EUR: Winnings tax of 15 % (on the amount exceeding 100 EUR)

Winnings from 500.01 EUR and above: Winnings tax of 20% (on the amount exceeding 500 EUR)

Winnings' write-off

1. The right to collect winnings deriving from the Participation in POWERSPIN via Agencies is limited after the lapse of three (3) months as of the date of conduct of the draw, pursuant to the provisions of the General Regulation on the Organization, Operation and Conduct of OPAP S.A. Games. Following the lapse of the aforementioned period and in extraordinary cases, OPAP S.A. may pay winnings to ticket holders when, without being at fault, they did not collect their winnings in time, nor did they claim them within the same period.

Winnings' Payment

Winnings are set forth based on the wager amount multiplied by the following odds' table:

1. Number: 24 times the wager
2. Doubles: 12 times the wager
3. Trebles: 8 times the wager
4. Quadruples: 6 times the wager
5. Six numbers: 4 times the wager
6. Eight numbers: 3 times the wager
7. Twelve numbers: 2 times the wager
8. Symbol: 8 times the wager
9. Zone: 3 times the wager

The maximum winnings' amount per wager is 1,000,000.00 EUR.

Payment of Winnings deriving from the Participation in POWERSPIN via Agencies:

a) Winnings are always paid to the bearer of the ticket, and in case of ticket loss, any claim of winnings' payment or other compensation will be excluded. In case a ticket is destroyed or in

case its details are altered, or in any other case that their identification or recovery by the Central Computerized System (CCS) is not feasible, it will not be deemed valid and any claim of winnings' payment or other compensation by OPAP S.A. will be excluded.

b) Conducted as follows:

i) For gross winnings before taxes of up to two hundred (200) EUR per slip, conducted via the authorized OPAP S.A. points of sale.

ii) For gross winnings before taxes, from two hundred (200) EUR up to eight hundred (800) EUR per slip, conducted via the OPAP S.A. authorized points of sale. Upon relevant request presented by the rightful owner of the ticket, the payment is conducted via a financial institution partnering with OPAP S.A., following the issuance of a relevant winnings' payment order by authorized points of sale designated by OPAP S.A.

iii) Gross winnings before taxes exceeding the amount of eight hundred (800) EUR per slip, are exclusively paid via a financial institution partnering with OPAP S.A., following the issuance of a relevant winnings' payment order by authorized points of sale designated by OPAP S.A.

v) The process followed by OPAP S.A. for the issuance of the winnings' payment order allows for the identification of the person who presented the payable slip.

2. Upon winnings' payment, OPAP S.A. directly withholds the corresponding tax, pursuant to the applicable legislation.

3. Payable amounts per win are truncated to the first two decimals.

4. OPAP S.A. may withhold the payment of winnings in exceptional cases, when according to its opinion, there is a possibility that the person collecting the winnings is not indeed the rightful owner of the ticket. In the case of winnings deriving from the Participation in POWERSPIN via Agencies, the cases of loss or theft of the entry ticket are indicatively mentioned.

5. In any case, the details of confirmed entries, per the applicable legislation regulating the matters of games of chance, constitute the sole evidence for the winnings acknowledgment, and in case of dispute, they prevail over any other evidence. Regarding the participation via Agencies, entry tickets constitute the proof of the payment due, in case of win, but only if it holds the same details as the ones already confirmed.

Winnings' Certificates

OPAP S.A. furnishes Winnings' Certificates following an online request, submitted by the Player pursuant to the Policy on Certificates of Winnings of OPAP S.A. within the subsequent fiscal year than the one during which the winnings were collected, and until October 31st (unless the Company extends the aforementioned deadline via an announcement posted on its website www.opap.gr).

A Winnings' Certificate is exclusively furnished for winnings collected via credit institutions.

No winnings' certificates are furnished for gross winnings before taxes, of less than two hundred (200) EUR per entry.

Regulatory Authority
